2. Wellington Fire Department Report

Desmond Arsenault, President attended the meeting and discussed the following items:

Calls: 3 calls, 1 medical calls, 1 fire pole, and 1 brush fire.

- The new forestry truck has arrived.
- The WFD received an award from the Muscular Dystrophy organization for their fund raising efforts.
- The WFD will do the BBQ on Canada Day in Wellington.
- Ongoing promotional events are taking place: event at École Évangéline Tintamarre, Cap enfants is visiting the firehall
- EMO meeting prep for emergency management during disasters
- Chief Leon Perry attended the Mutual Aid meeting
- The second boot drive will be held shortly
- The department received extra Covid-19 surplus supplies: masks, thermometers, gloves, etc. which will be used over the next few years when needed

6. Business arising from the minutes

a. Collège de l'île

Moira attended two meetings in June regarding a strategy in moving forward for le Centre scolaire Communautaire – *Plan de développement Communautaire de la région Évangéline.* At the June 12th meeting, Aubrey Cormier, Consultant, presented the plan to the members. With the construction of the new school, and the partnerships established, it is important to look at the usage of the facilities for trades, arts and culture.

There is a concern that the French speaking population at home is lower every year as a result of the decreasing population.

The plan has two strategic axis: A) Construction identitaire (Culture Identity) B) Capacités communautaires (Community capacity) and C) Engagement Communautaire (Community Engagement).

The Immigration Strategy is another component to be included in the plan.

The plan will be presented at the AGM next week and the final report will be completed by the end of summer.

b. Affordable Housing

A new funding program, Housing Accelerator Fund, is available to support Affordable Housing Developments in rural and urban areas. Wellington situates itself in the rural stream which requires 5 initiatives to support new housing projects. CAO setup a meeting with the three subdivision owners, a member of Council, Jason Maddix, Immigration Francophone, and Alcide Bernard who was involved previously for the village. The three developers stated their needs and will submit their requests which will help us guide the action plan for the fund submission. A report of this meeting is available.

d. **Pollinators park** - The work is being done in the selection of plants and much work goes in to the planning of the site. A shed was ordered and will be ready shortly. a. Fire Department Equipment Project

- d. **Asset Management Program** CAO discussed the need to continue the work on the Asset Management Program and suggested to work with Land Technologies to update the work done over the past year.

e. Discussion with Abram-Village Mayor - New CAO update

Irene spoke with the mayor of Abram-Village on the CAO agreement. He feels it is not necessary and they hired a bookkeeper and a possible administrator. He does not feel the agreement is required. They were informed that they have to write a letter to indicate that they wish to be removed from the agreement three months in advance.

The mayor also indicated that it may be an idea to amalgamate with Wellington. Council discussed this and noted that if the idea is brought formally, they would discuss with both Councils.

f. Child Care Centers Consultation

Irene participated in a consultation with representatives of the Department of Acadian and Francophone Affairs on the matter of child-care in the Evangeline region. It was more about the needs for the school child-care center.
